The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector. In 2021-22, the Council made payments totalling £7,680 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use
 of resources.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

Transparency

The Council should ensure that meeting minutes, supporting papers and decisions are published. The Council should ensure that they also publish the register of Members' interests on the Council's website. The Council should ensure that they publish full copies of its prior year annual return including the accounting statement, AGS and the audit opinion.

I recommend that the Council publishes all relevant information relating to Council business on its website in the interest of being open and transparent.

One Voice Wales Model Financial Regulations

We recommend that the Council reviews and formally adopts new standing orders and financial regulations. Model documents are available from One Voice Wales.

Immaterial Classification Error

The Council has made a classification error when transposing the cashbook into the annual return. Staff costs are understated by £548.32 and other payments are overstated by £548.32.
